

SCHOLARSHIPS FOR 2012

The Berkeley Community Fund's scholarship programs are designed to provide financial and personal support for deserving and resilient Berkeley public high school students attending 4-year colleges on a full-time basis. This year, between 12 and 15 scholarships of \$16,000 – payable in installments of \$4,000 per year for four years – will be awarded, based on demonstrated financial need, academic and personal achievement. Funds awarded by the Berkeley Community Fund (BCF) may be used for tuition, books, room and board and incidental expenses in connection with the recipient's college education.

SCHOLARSHIPS AVAILABLE:

The Berkeley Community Fund administers different programs:

- 1) **High Hopes Scholarships**: Four-year need-based scholarships (\$4,000 per year) awarded to Berkeley public high school students who will begin attending a 4-year college full-time in the Fall of 2012. Applicants must have a cumulative GPA over 2.5 in high school. Their high school work, including the courses they have taken and their extracurricular and outside activities, must demonstrate that they are ready for the challenge of college. These awards include individual mentoring and require recipients to be involved with BCF programs and events during their college years. High Hopes Scholars must remain enrolled full-time in college with a cumulative GPA over 2.25 to continue to receive these funds.
- 2) **The Berkeley High Class of 1951/BCF Scholarship**. Applicants for the Class of 1951 High Hopes Scholarship must have a cumulative **GPA of at least 3.5** and must attend a 4-year college in the Fall of 2012 on a full-time basis.

SELECTION CRITERIA

BCF will consider financial need, the application package and personal statement and
recommendations. We will be looking for academic achievement, reflected in the required GPA
in a challenging mix of courses throughout high school; other activities including in-school
positions, particularly those that reflect leadership and initiative; community service activities
and/or work experience. All finalists will be contacted and interviewed before the awards are
made.

AWARD PROCEDURE:

The scholarship committee will review all applications that are submitted by the deadline of **April 9**, **2012** and will invite finalists for an interview on **May 11**, **2012**. Recipients will be notified of BCF's decision no later than May 17, 2012, subject to confirmation of other financial resources, including scholarships and loans. All recipients will be honored at an Awards Ceremony, with their friends and families, on **June 4**, **2012**.

- Completed scholarship application, including Personal Essay. Applications can be downloaded at: http://www.berkfund.org beginning on January 19, 2012 or picked up at the BHS College/Career Center. Applications must be submitted in hard-copy form. NO ONLINE APPLICATIONS WILL BE ACCEPTED.
- 2. School transcripts (official or unofficial) from all high schools attended **showing your GPA**.
- 3. Copy of Student Aid Report (SAR) with expected family contribution (EFC) from the FAFSA. If a student in not eligible under FAFSA, he or she should explain and will still be considered by BCF.
- 4. Letters of recommendation from two adults: One familiar with applicant's academic achievement and one (not a relative) familiar with applicant's activities outside the classroom.

In addition to these materials, at the interview, candidates will be expected to provide information on the financial aid package or packages offered to them by colleges they are considering. BCF will not award any scholarship until the student provides all financial aid information.

- 4. A full-time student at a four-year accredited college or university in the U.S. in Fall 2012
- 5. Cumulative minimum **GPA over 2.5** in high school.
- 6. Must be available for an interview on Wednesday, May 11, 2012.
- 7. Must be available to **attend** BCF Awards ceremony on **Monday**, **June 4**, **2012**.

Berkeley High School Class of 1951/BCF Scholarship

Same criteria as above, except that the applicant must have a cumulative **GPA over 3.5** in high school.
